Meetings Attended BCCAT Forum on Dual Credit (April 17 – 19, 2016) o BC is experiencing a 20% increase in dual credit over the past year 0 75% of the programs are technical and trades Alberta's ACAT Dual Credit Articulation Committee Co-Chair, Rozlynn Wick (SAIT), provided a 0 presentation at the forum about Dual Credit in Alberta **ONCAT** Conference Their funding model and legal entity governance is different than Alberta's and is reflected in the type 0 and quantity of programming they can do Their Minister attended the event and talked enthusiastically about ONCAT's accomplishments and 0 ongoing work Alberta Post-secondary Learning Outcomes Workshop: Sharing Principles, Barriers, and Effective Practices (May 18, 2016) This is a joint initiative between ACAT, Campus Alberta Quality Council (CAQC), and the Ministry 0 Invitations have been sent to institutions to send 3 persons each, as well as to Council 0 Alberta Education requested an invitation to participate and are welcome to attend 0 LPMI Working Group Meetings – Advisory, Admissions and Transfer, Transfer Alberta Website/Search Tool A number of meetings have occurred and are ongoing with extensive participation/input from stakeholders regarding new transfer system modernization and tools **Residency Discussion** A research consultant for an Alberta institution met with the ACAT Chair and Ann Marie Lyseng 0 regarding residency and the impact on transfer Changes have occurred across Canada and discussion will continue at the Pan-Canadian Consortium 0 on Admission and Transfer (PCCAT) Conference in June. BCCAT (Rob Adamoski) has been leading an alignment of a provincial common application system in 0 conjunction with BCCAT's Education Planner for the transfer system. BCCAT has also connected with other jurisdictions/agencies, including ApplyAlberta, to gather information about their system for reference/research. BCCAT will share what it is able/appropriate from their application system information gathering and about their project when it is available.
