1.	*Welcome and Introductions	
2.	 Institutional Updates: Highlights Alisa McArthur (St. Mary's University) – there was some discussion surrounding the potential splitting of psyc 312 (research methods and statistics) into 2 half courses. Institutions provided input which indicated there is a variety of different means of instructions, however, the majority seem to split these courses (with University of Calgary being one of the exceptions). Wendy Hoglund (University of Alberta) – Wendy noted that some changes are being made in attempts to make entrance into the Honours program more accessible to students. Susan Boon asked if this was due to a drop in the number of Honours students. Wendy indicated that this was not the case, but more that there are typically more Science students and there is a push to have a more even distribution between Arts and Science students in the program. Cheuk Ng (Athabasca University) – looking to transfer Statistics to the Psychology department, from the Math Department. John Connors (Canadian University) – name is changed to Burman University. Mike Smith (Keyano College) – nothing new to report beyond the institutional update.	
Leanne Wilson (The King's University) – discussed the institutions new <i>Community Engaged Research Certificate</i> . This involves students being placed in a field setting. Mike from Keyano asked about who does the placements. Leanne indicated that they have a combined Psychology/Sociology hire that coordinates the placements.	
Kelly Mutter (Lakeland College) – Psyc 104 has been dropped as a prerequisite for Psyc 105. This lead to some discussion. This is the practice at a number of institutions (but not all). Nancy indicated that they are doing something similar at MacEwan so students in career paths that require 3 credits of Psychology are able to fill those credits with 105 (where the content is often a better fit for those students). There was some discussion about transfer concerns in these cases.	
Jennifer Davis (Lethbridge College) – the new senior administration is pushing to have faculty conduct <i>outcome-based</i> courses. This has not been supported by the Faculty at Lethbridge College and they are at an impasse with the Board. Articulation committee members expressed concerns over transferability, and support for the difficult position Faculty members at Lethbridge College find themselves in.	
Evelyn Field (Mount Royal University) – Evelyn had expressed regrets that she could not make the meeting. Members noted the large number of courses that were being dropped (as indicated in the institutional update document).	
Judy Swift (Northern Lakes College) – indicated that they are moving to have asynchronous course starts. Judy indicated that this was cost saving move.	
Gregory Wells (Red Deer College) – Psyc 312 was dropped as a prerequisite for Psyc 365 and 369. There are plans to develop an introductory psychology course for non-psychology majors. Gregory asked that after institutional updates we discuss the High School math requirements for the Psychology Statistics required course.	
Susan Boon (University of Calgary) – there was some discussion with regards

7.	College of Alberta Psychologists- Foundational courses Nancy Didgon brought this item forward and indicated that it has come to her attention that even though there are transfer agreements between institutions for certain courses, not all of these are accepted by CAPS. For example, a sensation and perception course at one institution may be accepted by CAPS, however, a similar course at another institution may not be accepted by CAPS (despite the fact that there is a transfer agreement between those 2 institutions). The problem seems to be in the numbering. That is, if the course is a 200-level course (that is at the 300-level at other institutions) then it is not accepted by CAPS. Nancy has expressed her concerns about this practice to CAPS and they have indicated that they do not see a problem with the practice. Members expressed their concern with this practice and agreed to have Nancy write a letter to CAPS expressing the concerns of the group.		
	Items Arising from earlier discussion a) Dorothy Steffler had earlier asked about the Introductory offerings across institutions. Following a brief discussion it became apparent that most institutions have 6 credits of introductory psychology (2 half courses). This lead to a discussion about seeing more Advanced Placement Psychology from High School and how that might transfer. The general consensus was that this would likely transfer as Psyc 203 (typically the second portion of Introductory Psychology). Mike expressed concerns (which were echoed by others) with regards to the qualifications of the instructors in such cases.		
8.	b) Greg Wells had earlier asked about the high school math requirements for entrance into the statistics requirement for the Psychology degree. In particular, if students need -1 or -2? There is variation among the institutions as to whether -1 or -2 is required. There was general consensus that -1 is probably not really necessary. Leanne Wilson indicated that they offer a non-credit course in the Fall of the 1 st year that helps students prepare for the math required for statistics. She indicated that she would pass on the information regarding this 'course' to Nancy and she would distribute it to the group.
