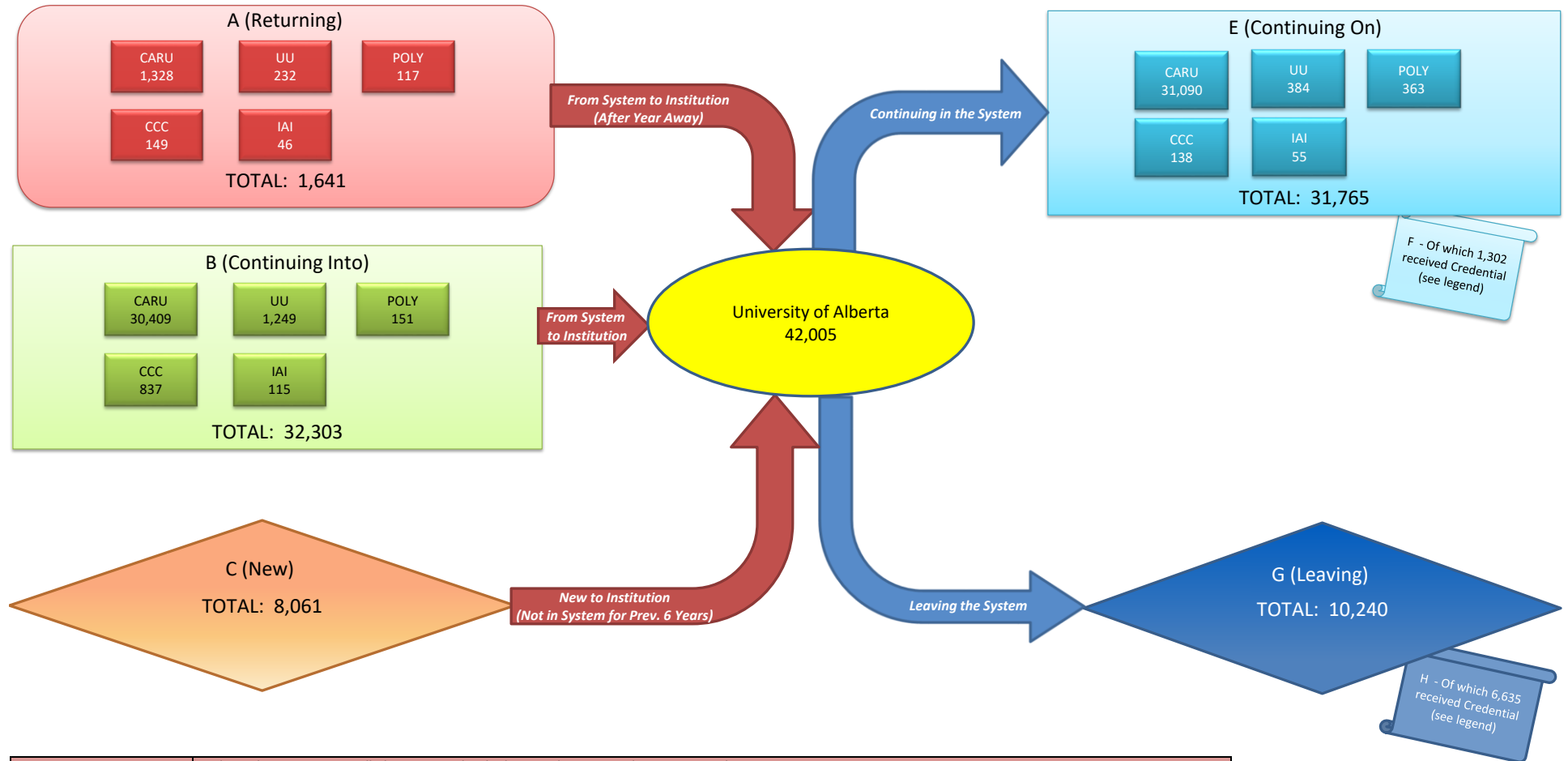

D (Student Cohort)	Students enrolled full-time or part-time in the institution(s) in the cohort year (2016-2017)
E (Continuing On)	Students enrolled in an institution for the following year (2017-2018)
F	Students enrolled in an institution for the following year (2017-2018), and received a credential from University of Alberta in 2016-2017
G (Leaving)	Students NOT enrolled at an institution in the following year (2017-2018)
H	Students NOT enrolled in an institution for the following year (2017-2018), but received a credential from University of Alberta in 2016-2017
