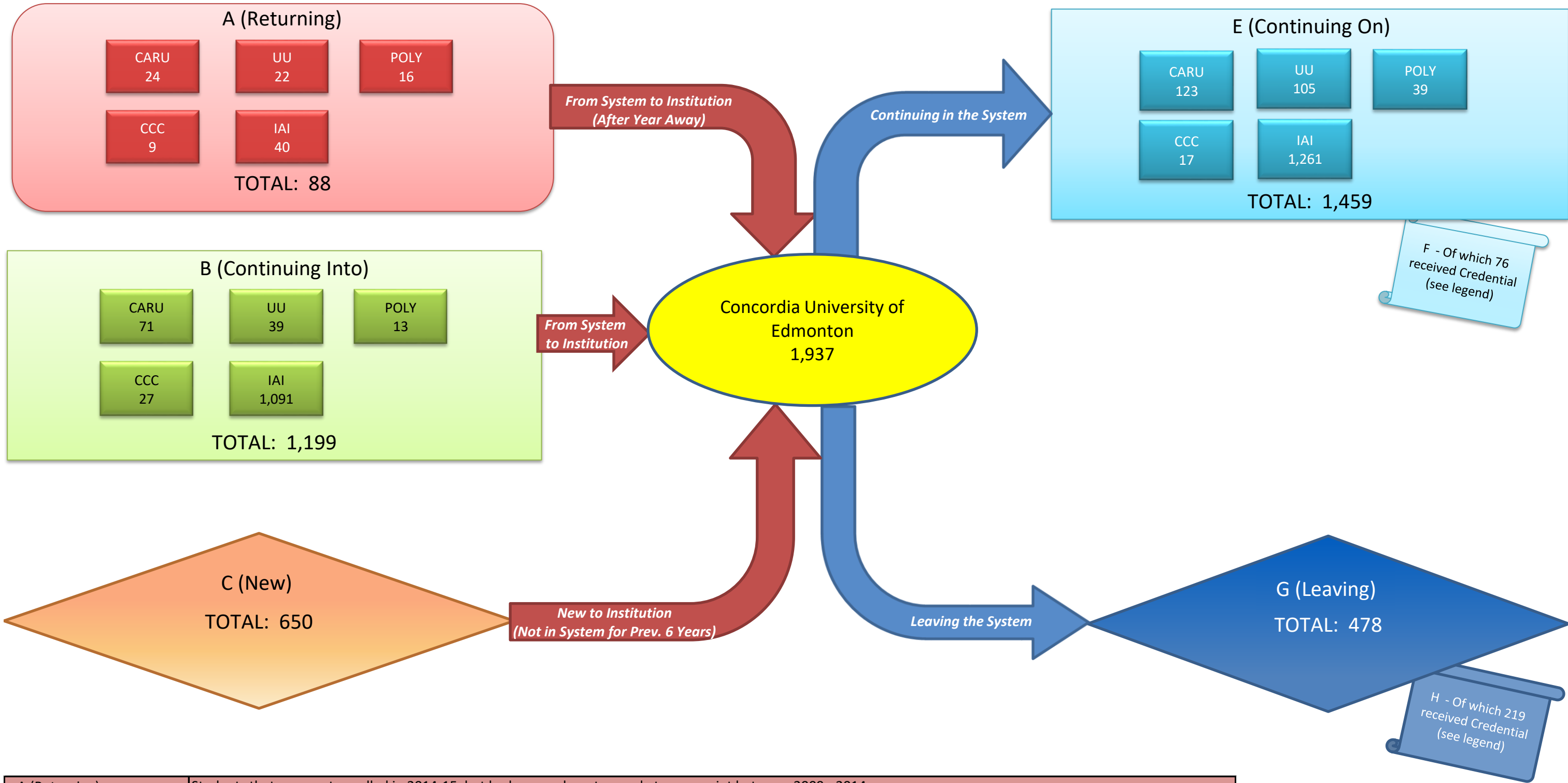


Institution Student Enrolment Flow

D (Student Cohort)	Students enrolled full-time or part-time in the institution(s) in the cohort year (2015-2016)
E (Continuing On)	Students enrolled in an institution for the following year (2016-2017)
F	Students enrolled in an institution for the following year (2016-2017), and received a credential from Concordia University of Edmonton in 2015-2016
G (Leaving)	Students NOT enrolled at an institution in the following year (2016-2017)
H	Students NOT enrolled in an institution for the following year (2016-2017), but received a credential from Concordia University of Edmonton in 2015-2016
