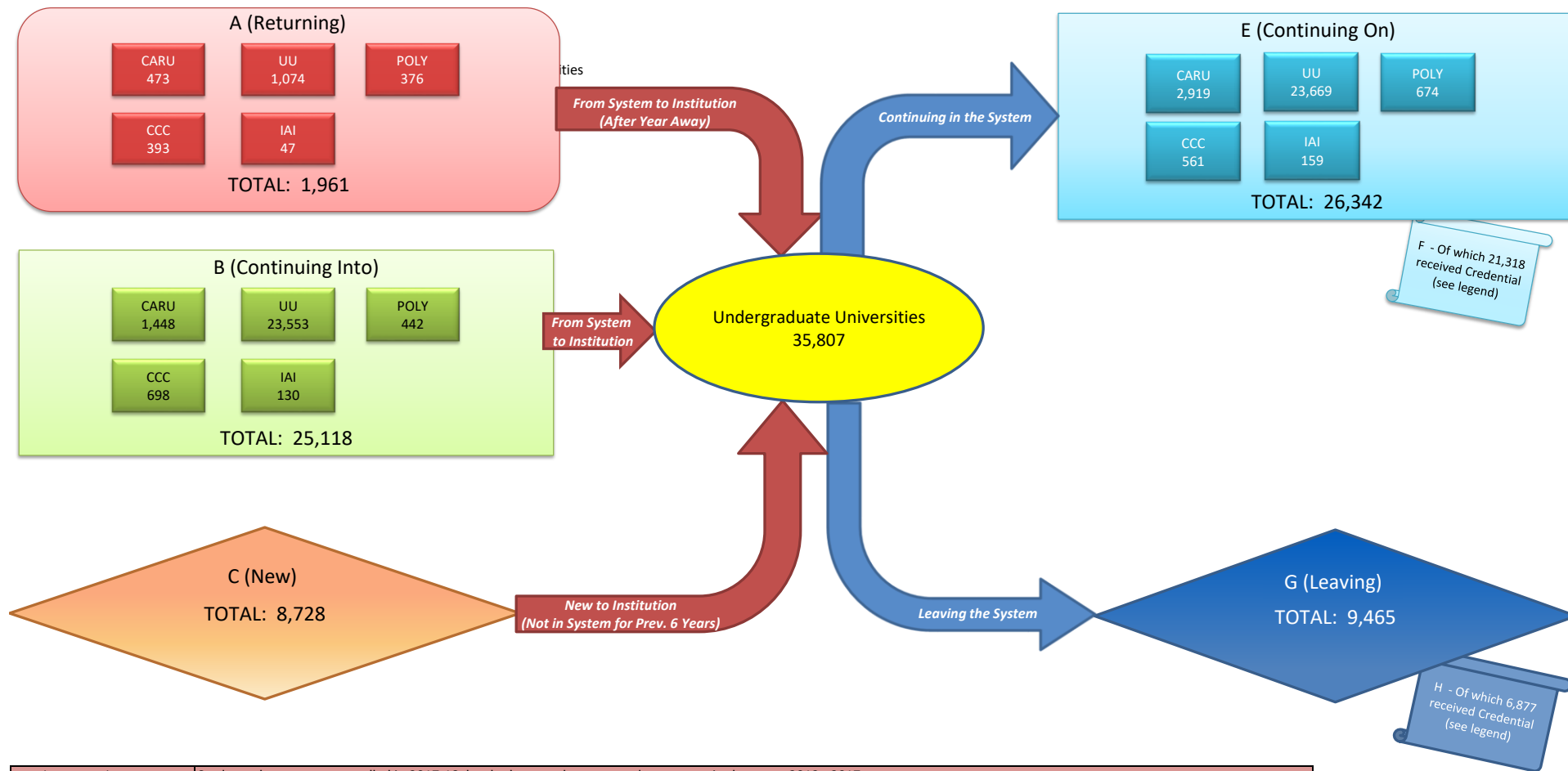


Sector Student Enrolment Flow

| F | Students enrolled in an institution for the following year (2019-2020), and received a credential from Undergraduate Universities in 2018-2019 |
| G (Leaving) | Students NOT enrolled at an institution in the following year (2019-2020) |
| H | Students NOT enrolled in an institution for the following year (2019-2020), but received a credential from Undergraduate Universities in 2018-2019 |

1. Values listed in the above diagram represent the number of Unique Students at the level you are looking at; therefore, adding up sector numbers in each category may lead to an inflated value.
